4 . First aid measures

6 . Accidental release measures

7 . Handling and storage

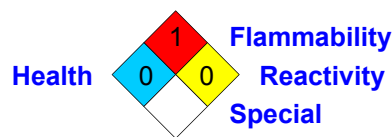

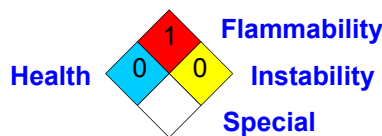
